The Forward Plan is a list of all the items which will be considered by the Joint Cabinet Committee.

Whilst the majority of the Joint Cabinet business at the meetings listed in this Plan will be open to the public and media organisations to attend, there will inevitably be some business to be considered that contains, for example, confidential, commercially sensitive or personal information.

This is formal notice under the Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012 that part of the Joint Cabinet Committee meeting listed in this Forward Plan will be held in private. This is because the agenda and reports for the meeting will contain exempt information under Part 1 of Schedule 12A to the Local Government Act 1972 (as amended) and that the public interest in withholding the information outweighs the public interest in disclosing it. Those items which are proposed to be considered in private are marked as such along with the reason for the exclusion in the list below.

If you would like to make representations or comments on any of the topics listed below, including the confidentiality of any document, you can contact the officer as detailed in the Plan. Your representations and any written response will be published on the Council's website, if possible at least five working days before Joint Cabinet Committee meeting. You can, however, make comments or representations up to the date of the meeting, which will be reported orally at the meeting. The Forward Plan will be updated monthly to enable you to check on the progress of the report you are interested in.

It has not been possible to give 28 days' clear notice as required by the Regulations in view of the urgency due to the time constraints involved in the Local Plan timetable.

Councillor Crump and Councillor Milton the Chairmen of the respective Overview and Scrutiny Committees have been informed.
